PAYMENT PLAN

Eligibility

We recognise that managing the expense of studying can be difficult so we provide the option of a three-part instalment plan to help you spread the cost of your London School of Marketing course when you enrol.

Eligibility Criteria

1. Students must have no outstanding balances from previous courses with the School.
2. Students must make a minimum of 50% deposit of the course fee, excluding the registration fee, on or before their induction to LSM.
3. Students must complete a Payment Plan Application and submit this with their application, along with all requested relevant documentation, for consideration by the Finance Department.
4. Payments are then made by direct debit** as follows:
 - ➔ First instalment (20% of total balance): payable 30 days post induction or on the 20th of the following month, whichever is sooner.
 - ➔ Second instalment (20% of total balance): payable 30 days after the first instalment payment.
 - ➔ Final instalment (remaining 10% of total balance): payable 30 days after the second instalment.

NB: Instalment deadlines are not negotiable for further extensions.
5. If any instalment payment is missed, the full amount owed becomes immediately due. A late payment interest charge of 8% will be charged immediately on the outstanding instalment balance and a late fee administration fee of £50 will be charged for each late instalment and will be payable immediately.
6. Failure to make payment when due may result in refused entry to courses booked (without any refund of any fees paid or liability on our part) and no further Payment Plan options will be made available.
7. We reserve the right to take legal action towards recovering all outstanding Payment Plans which have not been honoured.

The London School of Marketing Payment Plan is not available for students enrolling through Local Access Points.
